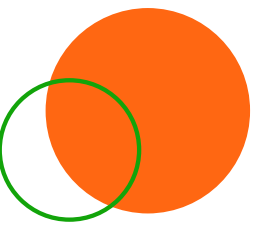

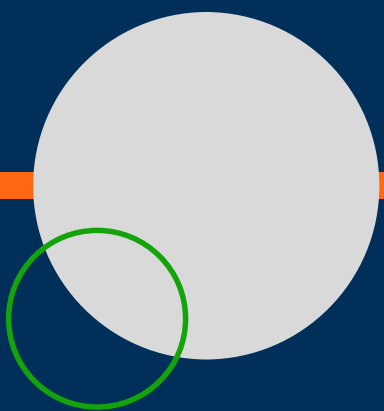

PERSON-CENTERED CARE

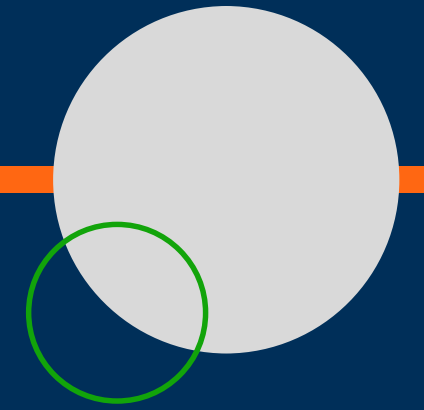
- ❑ HCSG is one of the largest employers of Registered Dietitians in the post-acute space, with approximately 900 professionals spanning 48 states
